

The unit features an Attenuator switch for padding the input signal by either 20 or 40 dB, and a Ground Lift switch which may reduce unwanted hum caused by "ground loops".

Input Jacks: 1/4" unbalanced jacks for receiving line or instrument level signals.


Attenuator switch: Reduces the input signal by the amount indicated.


Ground Lift Switch: In the "Lift" position, the ground connection of the XLR jack is disconnected from the chassis.
